ELECTRONIC INFORMATION SERVICES PERMISSION FORM

Student Name:

We are pleased to offer students of Crescent Park access to the district computer network for electronic mail and the Internet. To gain access to e-mail and the Internet, all school age students must obtain parent permission. Students are required to sign an acceptable use agreement.

Access to e-mail and the Internet will enable students to explore thousands of libraries, databases, and bulletin boards while exchanging messages with Internet users throughout the world. Families should be warned that some material accessible via the Internet may contain items that are illegal, defamatory, inaccurate or potentially offensive to some people. While our intent is to make Internet access available to further educational goals and objectives, students may find ways to access other materials as well. We believe that the benefits to students from access to the Internet exceed any disadvantages.

District Internet and E-mail Rules

Students are responsible for good behavior on school computer networks just as they are in a classroom or a school hallway. Communications on the network are often public in nature. General school rules for behavior and communications apply. The network is provided for students to conduct research and communicate with others. Parent permission is required. Access is a privilege – not a right. Access entails responsibility.

As outlined in Board policy and regulations, the following are not permitted:

- sending or displaying offensive messages or pictures
- using obscene language
- harassing, insulting or attacking others
- violating copyright laws
- using others' passwords
- trespassing in others' folders, work or files
- intentionally wasting limited resources
- employing the network for commercial purposes unless the activity is directly related to a school based program and receives prior authorization from the school.

Violations will result in a loss of access and possibly other disciplinary or legal action.

Parent Permission Form

I understand that individuals and families may be held liable for violations. I understand that some materials on the Internet may be objectionable.
